Session **VOTED** to approve the minutes of the 05/19/2020 Session Stated meeting with corrections from Elder McHugh.

STANDING REPORTS

- 1. Financial Report Chad Poole, Bookkeeper
- a. Chad had previously distributed the four standard reports, via email before the meeting. He reviewed significant items of interest. There were no questions.
- b. Two funds for the TransAsylee Project have been established, to facilitate and clarify whether the funds were received from within the congregation, or from funding sources outside the congregation.
- c. The Year-To-Date Income and Expense report is attached to these minutes.

2. Pastor's Report – Rev. Robert Woodruff

- a. The Lopez family were discussing having a memorial for David Lopez, but have postponed the memorial, indefinitely.
- b. We are making significant progress in increasing the procedures for handling and accounting for TransAsylee funds received both within and outside the congregation. Funds received from the City of Albuquerque were received as reimbursements for already vouchered expenses. The process was complicated by the fact that the City sent the funds to St. Michael's and All Angels Episcopal Church, instead of directly to Second, because of an established relationship between City personnel and persons at St. Michael's. Funds received from St. Michael's are already vouchered. We expect another \$8,000 from the City of Albuquerque.

Session **VOTED** to transfer directly to Alma Rosa Silva-Buñuelos, via check, the remaining \$6,400 of funds received from the City of Albuquerque, via St. Michael's and All Angels.

3. Parish Associate's Report - Rev. Kay Huggins

Pastor Kay requested impressions and reactions on her proposed Bible Study on Joel, to be held via video-conference (Zoom). Session provided favorable comments. Kay will schedule the classes beginning in July.

4. Deacons' Report – Lorraine Romero, Deacon Representative

- a. The Deacons have communicated and checked in with all Furthest Pew members, and other members and friends of the congregation. Communications sent by email by the Pastor and others continue to be printed and mailed to those without email who are interested in receiving the communications.
- b. The next meeting of the Deacons will be on Sunday, June 14, 5:30pm, by video-conference (Zoom).

COMMITTEE REPORTS

1. Building & Grounds – Abel McBride

- a. We are in the process of installation of air conditioning in the TransAsylee apartment. Our selected company is very busy, and will probably cause us to look for some other company to make the installation.
- b. We request the Safety and Security Ministry to provide us with the locations of the current cameras, and ensure Second has continuing membership in the camera monitoring system. We probably need to have another camera installed for full coverage.
- c. Our building custodian is keeping our building and grounds in good shape.
- d. Abel remains very nosy.
- e. The broken window on the ground floor, south side of the Candelaria Wing, is scheduled to be repaired on Wednesday, June 3. We realized some savings by our custodian doing part of the work.
- f. Pastor Rob has bids for the repairs of our stained-glass windows. The recognized expert that inspected our windows recommended a company to make the repairs. The estimate is \$5,000-\$6,000. Our insurance company considers each window to be an incident, so there would be a deductible on each window. It doesn't make sense to submit a claim.
- g. The air conditioning for the church offices need to be enabled. Abel will check with our custodian to open the water lines and turn the units on.
- h. Abel will soon transport recyclable materials to one of the recycling companies, and requested that anyone having any metal to call him.

2. Worship and Music – Allan Holmquist

- a. Allan, Pastor Rob, and Karmen have discussed several scenarios and considerations for holding an outside service of worship at Menaul School, Hart Park, on June 14. They will meet Wednesday, June 3, to start construction of the order of worship. They will be flexible in their plans.
- b. We are making progress on completing and submitting our request for a Grant for audiovisual equip for to produce streaming worship from Second's sanctuary.
- c. Prayer and worship are important in the struggle for justice!
- d. The sound system that Menaul School is willing to provide is terrific. It will probably be on the North side of the Hart Park area. Isaac Ploof will play much of the service and use a mask when not playing his clarinet.
- e. We are considering using a track from a choir CD that was made a few years ago. If we can't provide direct output into the sound system, we could simply hold the device (phone) up to a microphone.

- f. After significant conversation, and Pastor Rob ensuring each Session member expressed a view, we decided by consensus to wait some more time before proceeding with plans for inperson worship. Rob will notify Menaul School.
- g. We noted that outside worship is far safer than inside; that an inside sound would be better than outside; that in our sanctuary, observing safe spacing, the maximum we could safely accommodate would be 75 persons. Indoor worship could be a significant time in the future.
- h. Session agreed to resume consideration of in-person worship during our Stated meeting on June 23.

3. Stewardship & Finance – Eli Lopez

- a. The Committee has not met since the beginning of the health crisis.
- b. Our Paying Treasurer, Lynn Gatewood, continues to write checks.
- c. I consider our Counters to be heroes.
- d. Thanks, and blessings to our faithful givers!
- e. Pentecost is past, and there will be a lag time with giving and counting donations designated to the Pentecost Offering. We are happy that 40% of the Pentecost Offering stays with us.
- 4. LiveWire George Huggins; Members: Lauren LaMonica, Alicia Montoya
- a. 2020 Budget LiveWire has obligated \$686 of its \$2,229 budget for 2020. We have 69% (\$1,5433) of our budget remaining for the approximately 59% of 2020 remaining.
- b. 60 have installed Instant Church Directory on their handheld device.
- c. In the last 30 days our website had 1,033 unique visits.
- d. In the last 28 days our FaceBook page had 82 views and 142 followers.
- e. May newsletter sent USPS to 180; electronically to 91.
- f. Breeze users/roles: Admin, 4; Financial, 7; Member, 3; Pastor, 1; Standard, 1.
- g. We oriented about 8 to the digital church.
- h. We provide orientation to Zoom videoconferencing to about 14, including 3 Session clerks from other congregations.

5. Evangelism & Membership – Steve Montoya

We hope to organize a new members' class! Steve is in the process of receiving transfer of information from the previous Committee chair.

6. Christian Education – Karmen Van Dyke

- a. Our Corona Vacation Bible School (VBS) will focus on Isaiah captivity and a New Day! Planning is being coordinated by First. Each participating church will be responsible for packets to be distributed to its participants. VBS will be held thru the month of July. Each family will have the option to use as much or as little of the materials as per your family situation.
- b. Children's Choir Director, Debi Eisenhour, is considering options for music education using video-conferencing. She has had some experience thru her school.
- c. Elizabeth Korver-Glenn and her children starred in a video that was texted to parents to show to their children.

d. During the Sunday Zoom Fellowship Coffee, the Sunday School break-out is using thinking inside the box!

7. Mission – Anna Torres

We are scheduled to participate in Project Share on June 27. Martha Powers will contact the usual suspects!

The next meeting of Session will be our June Stated Meeting on June 23, at 5:30pm, via Zoom.
